Dear Weatherstone Homeowner:

We are happy to announce the opening of the swimming pool on Monday, June 15th.

Hours of operation are as follows: Daily Hours – 12:00 Noon to 8:00 p.m.

June - 15<sup>th</sup> – June 30<sup>th</sup>

July – 1<sup>st</sup> to 31<sup>st</sup>

August – 1<sup>st</sup> to 31<sup>st</sup>

September 1<sup>st</sup>-7<sup>th</sup>

Due to the pandemic, we are required to follow strict guidelines set forth by the State of Pennsylvania. Everyone must comply with the following:

- 1.) At this time, the number of individuals using the pool will be limited to 25. Please note that this number may change as the summer progresses.
- 2.) Everyone must sign in upon entering the pool area. (TWO PASSES PER HOME ENCLOSED)
- 3.) NO guest allowed at this time.
- 4.) Social distancing will be required in the pool and on the deck.
- 5.) No toys, flotation devices, noodles or kickboards will be allowed at this time.
- 6.) Facemasks are recommended, and may be required at some point, in the pool area for those over the age of 12. There is no mask requirement while in the pool.
- 7.) No more than 1 person or 1 parent with a child will be permitted in the bathroom at one time. A spray bottle with disinfectant will be available in each bathroom. Please disinfect anything that was touched.
- 8.) No community furniture will be provided. A resident should bring his own chair, umbrella, blanket.
- 9.) The lifeguards will be disinfecting gates, ladders, railings and bathroom fixtures every two hours. This may cause a mandatory break in pool usage for 10-15 minutes.
- 10.) Hand Sanitizer will be available at the entrance. Feel free to use it.

These directives from the PA division of Public Health may change throughout the season.

Please take the time to review the information we have provided.

The Association has contracted with Progressive Pool Management Inc. to operate and manage the pool this season.

#### **Be Safe and Enjoy the Pool**

Watch your children and supervise their behavior. Climbing on fences is unacceptable.

Glass is prohibited in pool area. Alcohol and smoking are also prohibited.

No running, diving, cannonballs, ball playing or rowdiness permitted. Lewdness and cursing prohibited.

Flotation devices, inflatables, and water toys will be permitted solely at the lifeguard's discretion.

Children in wading pool must be with a responsible adult age, 16 or older. Swim diapers may be worn in the wading pool.

Lifeguards must be obeyed. Three warnings from lifeguard and you'll be out of the pool for the day. Excessive/chronic violations may result in pool membership being rescinded after review by the WS Board and Pool Committee. Bathers must exit pool during lifeguard necessity breaks.

#### **Be a Good Pool Citizen**

Eating and drinking is permitted only at chairs, tables and lounges. No food or beverages may be consumed poolside.

Only working service animals permitted. No other pets are allowed at the pool.

Keep restrooms neat and orderly. Children 8 and under must be accompanied by adult to restroom.

No diaper changing on chairs, tables or lounges.

Keep pool area clean and tidy by disposing of refuse in trash receptacles. Remove all personal items when leaving pool area.
